



OFFICIAL RULES

Contest Title: "Recharge Under the Sun" (the "Contest")

From April 1 to June 30, 2025

1. **Organizer.** The Contest is held by Guillevin International Co. (individually and collectively, the "**Organizer**" or the "**Contest Organizer**").
2. **Duration.** The Contest runs for the following Period ("**Contest Period**").

Start of the Contest:

Date : April 1, 2025

Time: 12:00 a.m. (Eastern Time)

End of the Contest:

Date: June 30, 2025

Time: 11:59 p.m. (Eastern Time)

3. **Eligibility.** The Contest is open to residents of the province of Quebec who have reached the age of majority at the time of entry.

Excluded: directors, officers, managers, employees, agents, and representatives of the Contest Organizer, any Profit Center, advertising and promotional agencies, prize suppliers, as well as persons with whom they reside (whether related or not).

4. **How to Enter – With or Without Purchase.**

No purchase is required to participate or win. A purchase does not increase the chances of winning.

The Contest is held in participating Profit Centers in Quebec and on guillevin.com (the "branches").

A. Entry With Purchase:

i) For the Grand Prize:

Purchase a minimum of CAD \$5,000 worth of eligible products (excluding Back Orders) during the Contest Period to be automatically entered into the grand prize draw.

ii) Monthly Secondary Prizes:

April Draw Eligibility :

- Purchase a minimum of CAD \$2,500 in eligible products between April 1 and April 30, 2025. Purchases can be made in-branch or online at guillevin.com. The number of chances varies by purchase channel – see details below. Back Orders (B.O.) are not eligible and do not count toward the minimum purchase.

May Draw Eligibility:

- Purchase a minimum of CAD \$2,500 in eligible products between May 1 and May 31, 2025. Purchases can be made in-branch or online at guillevin.com. The number of chances varies by purchase channel – see details below. Back Orders (B.O.) are not eligible and do not count toward the minimum purchase.
- Transactions must be made using a Guillevin business account.

June Draw Eligibility:

- Purchase a minimum of CAD \$2,500 in eligible products between June 1 and June 30, 2025. Purchases can be made in-branch or online at guillevin.com. The number of chances varies by purchase channel – see details below. Back Orders (B.O.) are not eligible and do not count toward the minimum purchase.
- Transactions must be made using a Guillevin business account.

All Back Orders and Lots billings are not eligible to the promotion.

Increase Your Chances of winning:

Once eligible for any draw, chances of winning a prize increase based on purchase channel:

- In-branch purchases: 1 chance per CAD \$500
- Online purchases: 3 chances per CAD \$500

Returns and Refunds. Any returned product that is refunded may lead to disqualification from the Contest at the Organizer's discretion. Participants may then opt for the no-purchase method of entry.

B. Entry Without Purchase.

To receive a no-purchase entry ballot, send a legible, original handwritten letter of at least 50 words explaining which draw you wish to enter and why you would like to win. Include your full name, address (including postal code), phone number, and email address. Mail your letter in a properly stamped envelope to:

Deadlines:

Your letter will be validated by a representative of the Organizer, and your entry will be added to the database for the draw.

Limits. Participants must comply with the following limits (for both purchase and no-purchase entries), otherwise they may be disqualified:

- Only one (1) prize may be won per person, per household.
- Only one (1) no-purchase entry request per person per properly stamped envelope. Each letter must be different
- A maximum of five (5) letters will be accepted for those participating solely through the no-purchase entry process.

Travel Credit Conditions::

6. Draws.

A. GRAND PRIZE:

B. SECONDARY PRIZES:

April Draw Date: Wednesday, May 14, 2025

Draw Time: 1:00 p.m.

The draw will take place at the Organizer's offices, located at 6555 boulevard Métropolitain E, Suite 301, Montreal (Quebec), H1P 3H3.

Draw Details: Twenty-five (25) eligible entries will be randomly selected from all valid entries received during the Contest Period.

May Draw Date: Wednesday, June 18, 2025

Draw Time: 1:00 p.m.

The draw will take place at the Organizer's offices, located at 6555 boulevard Métropolitain E, Suite 301, Montreal (Quebec), H1P 3H3.

Draw Details: Twenty-five (25) eligible entries will be randomly selected from all valid entries received during the Contest Period.

June Draw Date: Wednesday, July 16, 2025

Draw Time: 1:00 p.m.

The draw will take place at the Organizer's offices, located at 6555 boulevard Métropolitain E, Suite 301, Montreal (Quebec), H1P 3H3.

Draw Details: Twenty-five (25) eligible entries will be randomly selected from all valid entries received during the Contest Period.

7. Prize Claim.

To be declared a winner, any selected participant must:

- Be contacted by the Organizer by phone or email within ten (10) business days following the draw. If the participant cannot be reached within this time despite reasonable efforts, they will be disqualified and another participant will be selected.
- Complete, sign, and return the Declaration and Liability Release Form provided by the Organizer within two (2) days of receiving it.
- Correctly answer the mathematical skill-testing question without assistance.

Failure to comply with any of the conditions set out in these rules or refusal to accept the prize will result in disqualification of the selected participant.

To be officially declared a winner, the selected participant must complete the following steps:

a) Winner Notification

- The Organizer will contact the selected participant by phone or email within ten (10) business days following the draw.
- If the participant does not respond after several reasonable attempts, they will be disqualified, and another draw will be held to award the prize.
- In the case of notification by email, the participant must respond by following the instructions provided. If the Organizer receives a bounce-back message indicating the email address is invalid or non-functional, the entry will be disqualified.

b) Prize Acceptance

To validate their eligibility and receive the prize, the winner must:

- Sign and return the Declaration and Liability Release Form provided by the Organizer within two (2) days of receiving it.
- Correctly answer a mathematical skill-testing question without mechanical or other assistance.

If the participant fails to meet these conditions or refuses the prize, they will be automatically disqualified, and a new draw may be held.

c) Prize Refusal

If a winner refuses to accept the prize under the terms outlined in these rules, they will be deemed to have forfeited any claim to the prize. The Organizer will then be released from all obligations toward that person.

d) Prize Awarding

- No prize may be transferred to another person, exchanged for another product, or redeemed for cash, except at the sole discretion of the Organizer.
- The Organizer reserves the right to substitute a prize (or part of it) with another of equal or greater value if the original prize becomes unavailable for reasons beyond its control.

e) Prize-Related Expenses

All costs or expenses incurred by winners in claiming or using their prize are the sole responsibility of the winners.

8. General Conditions

Disqualification. Any participant who does not comply with these rules may be automatically disqualified from the Contest.

Declaration and Liability Release Form. By participating, selected individuals release the Organizer, its affiliates, agencies, and partners from any liability related to participation in the

Contest or the awarding of the prize. Winners must sign a form confirming their eligibility and releasing the parties from any liability.

Limitation of Liability. The Organizer is not responsible for technical errors, printing mistakes, incomplete transmissions, or failures of any network or equipment. No liability shall be assumed in the event of technical or human errors affecting the management of the Contest or the receipt of entries.

Cancellation, Suspension, or Modification of the Contest. The Organizer reserves the right to cancel, suspend, or modify the Contest at any time if circumstances beyond its control prevent the Contest from proceeding as planned.

Personal Information. Personal information collected is used solely for the administration of the Contest and the awarding of prizes. By accepting a prize, winners consent to the use of their name, city, and photo for advertising purposes without compensation.

Participant Identification. The participant is the person in whose name the account is registered and to whom the prize will be awarded, if declared a winner. In the event of a dispute, the account holder will be deemed the participant.

General Provisions. Participation in the Contest implies acceptance of these rules and the Organizer's final decisions. The Contest is governed by applicable laws. If any provision is found to be invalid, the remainder of the rules shall remain in effect.
